The political season in Maine is in full swing! Election Day is right around the corner; and our brand new web site is now live at www.lwvme.org, full of valuable information about the upcoming election and voting, as well as League activities and issues.

Election Day is November 6, 2007. This is an off-year election, but there are some important questions on the ballot. Be sure to vote on November 6. The League has been out front in favor of a "Yes" vote on Question 5 to extend term limits. The state ballot also puts bond and gambling questions to the voters of Maine. These questions are important to our future!

With the Presidential primaries well underway and campaign spending expected to break all records, our continuing work for campaign finance reform could not be more important, defending Maine's landmark public funding system. And our newly-formed PAC Study Committee is now at work, studying the impact of political action committees on candidate races here in Maine. An item in the October Members Update particularly caught our eye. The Maine Historical Society is presenting a program on Woman Suffrage.
